Privacy Policy

The Privacy of your personal information is important to us. We take great care to properly handle information about you. This Privacy Notice describes our current privacy policy and practices for safeguarding your personal information and our commitment to protecting your privacy.

CONFIDENTIALITY AND SECURITY

We follow strict security standards and procedures to help prevent unauthorized access to personal information. Only properly authorized employees may access information we collect from you or about you. INFORMATION WE COLLECT

We may collect information about you from the following sources:

Information we obtain from third parties. This type of information may include claim reports, medical reports and similar information obtained from your healthcare provider with your authorization.

Information we obtain through transactions and experience. We develop and retain information based on our transactions and experience with you, such as your claims history.

INFORMATION WE SHARE

We do not sell or rent information we have about you to anyone. We may share the information we collect about you as authorized by you or permitted by law:

With business associates. for a variety of purposes including:

- to assist us in providing service and account maintenance; and
- to assist you in minimizing completion and filing of multiple forms; and
- to assist us in coordinating delivery and payment for your healthcare services.

When information about you is disclosed to our business associates, we expect them to protect your information and use it only for the limited purpose for which it was disclosed.

With third parties. We may disclose the information we collect about you in response to a subpoena, to prevent fraud, to comply with an inquiry by a government agency or other regulator or as necessary for other legal purposes. We may also disclose the information we collect about you to insurance carriers in the process of soliciting insurance proposals or placing insurance coverage.

MEDICAL INFORMATION

We do not share medical information, with our business associates or with third parties for any purpose other than for providing and servicing your benefit plan, claims or contracts; as allowed by the relevant laws protecting your privacy; or in circumstances where you consent.
